Central Park and Ten Oaks are both located in The Energy Corridor. Central Park is the largest parcel of land open for development in this thriving sub-market and Ten Oaks is located alongside the Texas Medical Center – West Campus. Finally, Gates Ranch is a 1,500-acre community of family farms in Washington County. With a slew of recent sales, only four farm sites remain.
